## **BGU Player Re-imburement Policy**

The Boland Golf Union encourage our players to play in as many tournaments as possible at both regional and national level, and by doing so gain additional exposure and experience. The Union also understands the financial implication of participating in these events and has implemented a Re-Imbursement policy to offer financial assistance to our players. The Re-Imbursement policy is broken into two categories.

- 1) Re-Imbursement based on Order of Merit position
- 2) Re-Imbursement based on performance at National Tournaments.

### **Re-Imbursement based on Order of Merit position**

Once the ranking has been cleared and a new season start, the BGU will pay the entry fees for the Top 3 ranked players who has logged the minimum required counting rounds to be eligible for team selection on their respective ranking until the conclusion of the ranking season.

All players must enter themselves for tournaments through the required method for a tournament (The BGU will not be entering on behalf of players). Should the player be ranked within the Top 3 of his respective ranking on the first day of the tournament, he will be able to submit a claim form for entry fee re-imburement. Claims must be submitted within two months of the date of completion of the relevant tournament.

On conclusion of the order of merit season, the top 3 ranked players will receive the lumpsum Rand value as set out below in either a voucher, as contribution towards your club membership, equipment upgrade or as credit towards upcoming entry fees.

#### **IPT Order of Merit**

1<sup>st</sup> – R3 000, 2<sup>nd</sup> – R2 000 & 3<sup>rd</sup> – R1 000

#### **Mid-Amateur Order of Merit**

1<sup>st</sup> – R3 000, 2<sup>nd</sup> – R2 000 & 3<sup>rd</sup> – R1 000

#### **Senior & Super Senior Order of Merit**

1<sup>st</sup> – R3 000, 2<sup>nd</sup> – R2 000 & 3<sup>rd</sup> – R1 000

#### **U19 Order of Merit**

1<sup>st</sup> – R3 000, 2<sup>nd</sup> – R2 000 & 3<sup>rd</sup> – R1 000

### **Re-Imbursement based on performance at National Tournaments.**

- Available for all Boland Affiliated male golfers in the Open, Mid-Am, Junior & Senior age categories.
- Players who have claimed for Re-Imbursement based on Performance must make themselves available to represent The Boland Golf Union should they be selected for representation.
- Players can only claim for Re-Imbursement on Performance for tournaments that counts towards the GolfRSA (NOoM) and consequently the BGU Ranking within their age category.
- Where a player travels to participate in more than one event, only the first event will be calculated as an away (applicable region) event and all following events will be calculated as local (Boland/WP) events
- Where a Stroke Play tournament is followed by a Match Play event, the Match Play event will be treated as a local 3-day tournament and payments will be made as follows: Winner =100%, Losing Finalist = 90%, Top 10 = 50%
- If a player is suspended from the Union on any charge, the player will be liable to pay back all monies claimed by the player for that specific season
- If the BGU paid the entry fee for the relevant tournament, this fee will be deducted from the reimbursement payment
- The Boland Golf Union will only accept claims submitted on the official claim form to the Boland Golf Union office.
- Claims must be submitted within 2 months from the date of completion of the relevant tournament.
